**ORDER**

In cancellation of earlier Order No. 196/PRD/XXIII-26/2010 dated 03.11.2010 of the undersigned and in terms of Notification no. 1368/PN/O/III/2A-18/02 dated 23.03.2007 read with memo no. 935/PN/O/III/2E-126/2008 dtd. 18.02.2010 of the Joint Secretary, Government of West Bengal, Department of Panchayat & Rural Development (Panchayat Wing) the following Sahayaks of different Gram Panchayat have been selected from the merit-cum-Seniority list of the eligible Sahayaks of Gram Panchayats, and promoted to the post of G.P.
