**ORDER**

As empowered by the Government communicated Vide G.O. No. 11243/SW dated 23.12.1974, I do hereby sanction the **DISABILITY PENSION** under **NON-PLAN HEAD** with effect from **01.04.2012** in favour of the following applicants as stated in Annexure with this order under the West Bengal Disability Pension Rules, 1974 including subsequent amendments by the Government from time to time.

1. The rate of aforesaid pension (enclosed Annexure) will be Rs. 750.00 (Rupees Seven hundred Fifty) only per month which may be changed subsequent Government Order in future.
2. The Pension sanctioned will continue until it is revoked, stopped, held up lapses due to death of pensioner or any other causes.
3. The amount of pension will be remitted by Post Office Savings Account only.
4. The Charges will be debited to the Head "2235-02-101-NP-005-V-31-02 - Other Charges" for Disability Pension sanctioned under **NON-PLAN** Head.
5. If the sanctioned pensioners get any other pension from any Other Department this will be treated as cancelled.
6. No G.R. will be given to the applicants.
