In terms of Notification No. 32367/SW dated 31/12/1987 of the Social Welfare Department, Government of West Bengal & its subsequent modification, I do hereby sanction the **WIDOW PENSION under HEAD NON-PLAN** to the following pensioners with effect from **01.04.2012**. The sanction of pension will be governed by Widow Pension Rules & subsequent modification, which had taken place or take place in future.

1. The rate of aforesaid pension will be Rs. 750.00 (Rupees Seven hundred Fifty) only per month.
2. The pension is sanctioned (enclosed annexure) to this order will continue until it is revoked, stopped, held up or got lapses due to death of the beneficiaries.
3. The amount of pension will be remitted by Post Office Savings Account.
4. If the sanctioned beneficiaries are getting any pension from any end, this will be treated as cancelled.
