ORDER

A sum of ₹ Rs. 59,05,000/- (Rupees Fifty Nine Lakhs and Five Thousand) only is hereby sub-allotted for construction of 31 Nos. of Kitchen-cum-Stores Shed under Purba Medinipur District. Fund has been allotted to 25 Nos. of schools for new construction @ ₹ 2,00,000/- to ₹ 3,05,000/- per unit, on the basis of new plinth area norms (Allotment No.93(Sanc)-ES(CMDMP)/Genl-25/2012-13 dated 25.02.2013 of the Project Director, CMDMP, School Education Department) and fund has been allotted to 6 Nos. of schools @ ₹ 40,000/- per unit, where grant @ ₹ 60,000/- was sanctioned earlier under Mid-Day Meal Scheme, and construction could not be completed (as per Memo No. 128(Sanc)1(40)/SE-MDM-32-2009(Pt-III) dt: 29-03-13).

Concerned Block Development Officers are hereby informed that the allotted amount as per the Annexure – I & II will be released through Bank Advice from the District Mid-Day Meal Account. She / He must take immediate measures for the construction of the said Kitchen-cum-Store Shed.

Utilization Certificates (in proper format), alongwith expenditure statement and photograph of the Kitchen-cum-Store Shed must be sent to the District Mid-Day Meal Section within 60 days from the date of receipt of this order.




