### General information for applicants:

- The term of a Chairman of Child Welfare Committee shall not be more than for a period of 3 (three) years from the date of appointment.
- The Chairman of the Committee shall be eligible for appointment of maximum of 2 (two) terms.
- Scope of work: The Committee shall sit on all working days for a minimum of six hours commensurate with the workings of a Magistrate Court, and for at least 20 days in a month.
- Residence : The candidate must be a resident of the district for which he / she is an applicant.

- A member selected by the Selection Committee should not
  - v) Be holding such full-time occupation that may not allow the person to give necessary time and attention to the work of the Committee.
  - vi) Be associated with any Child Care Institution, directly or indirectly, during his tenure as a member of the Committee or have any other conflict of interest.
  - vii) Hold any office in any political party during his tenure, or
  - viii) Be insolvent
- For additional information, candidates may refer to the Juvenile Justice ( Care & Protection of Children) Act, 2015 along with the West Bengal Juvenile Justice ( Care & Protection of Children) Rules, 2017
