ORDER

On recommendation of the West Bengal Group D Recruitment Board and in pursuance of Memo No. HAD/12M- 01-19/A 3458(58) dated 03/01/2019 issued by the Director of Health Services, Govt of West Bengal the following candidates are hereby appointed temporarily as **GDA** (General Duty Attendant) in the pay band scale of Rs. 4900-16200/- of PB-I with Grade Pay of Rs. 1700/- under WBS(ROPA) Rules 2009 plus usual allowances as admissible under Government orders issued from time to time and posted at the hospitals/institutions mentioned against their names in ANNEXURE-I until further orders. The candidates should download the appointment order from Departmental website (www.wbhealth.gov.in) and Purba Medinipur District Website (www.purbamedinipur.gov.in) and are directed to report for joining to the office of the undersigned within 30 (Thirty) days from the date of issue of this order otherwise appointment order in respect of the candidates shall be treated as cancelled without any further correspondence.

- Medical examinations of the candidates have been done and found fit.
- Police Verification is to be done for all candidate(s) as per Annexure- II attached here with & in case of any adverse report from police authority; the appointment(s) will be terminated forthwith.
- They are liable to be transferred anywhere within the West Bengal in exigency of public service.
- The appointments are provisional and liable to be terminated on one month notice or one month salary in lieu of one month's notice from either side.
- Three month notice will be necessary in case of resignation from the post and in absence of which one month salary will be forfeited.
- All the service conditions of the Gr. D category of staff will be applicable as per West Bengal Services Rules and subsequent orders/amendments issued from time to time.
- No TA/DA is admissible for the purpose of joining.


