

Applications are invited from the retired Govt. employees for filling up one vacant post of "LDC-cum-Typist" for carrying out the business of the Juvenile Justice Board (JJB), Purba Medinipur on contractual basis at a consolidated pay of Rs. 11,880/- per month for a maximum period of one year and the same may be renewed year to year on the basis of satisfactory performance of the incumbent up to the age of 65 years or till regular recruitment is made, whichever is earlier. 
