QUOTATION NOTICE

Sealed quotations are invited from the bonafied quotationers/bonafied transport vendors/Agencies for engagement of dry milk carriage vehicle :-

- Pick-up Van (preferably Mahindra/TATA pick-up van)or, other same type vehiclewith full side guard along with driver having capacity and permission to transport 1.5 to 2.0 MT
 - 'Mini Tempo' other same type vehiclewith full side guard along with driver having capacity and permission to transport 0.5 to 0.75 MT
- for collecting milk everyday all around the year i.e 365 days without interruption from different MPCs to Bulk Milk Cooling Unit(BMCU) & from different BMCU to Milk Chilling plant as per direction maintaining following criteria :-

- The quotationer should submit the offer in sealed envelope superscript with ' Quotation for Milk Carriage Vehicle' along with Xerox copies of valid permission of trade license, vehicle ownership paper or, contract paper with other vehicle owner, PAN, Voter card, ADDHAR, Bank Account etc.
- The quotationer has to be submitted in their 'own printed letter head' specifying the separate rate clearly in number and words for supplying dry vehicle along with driver(without any liability) per month basis.
- Vehicle should have valid blue book, road tax clearance, insurance paper and other relevant papers and permission for carrying the load capacity.
- The vehicle will run everyday all around the year without interruption. No leave or, holiday will be granted from the authority. If, it is require for maintenance, fitness, repairing of the vehicle substitute vehicle must be arrange for performing duty.
- Mainly the vehicle will be used for transporting milk, but it may be use for other official purpose if necessary as per requirement of the authority.
- The duty hours will be started at 6.00Am everyday positively from BMCU to diffèrent MPCs as per milk route for collection of milk with an ending at BMCU(1st trip) & after 1 hrs. interval from BMCU to Milk chilling Plant and back to BMCU after collecting evening milk from different MPCs(2nd trip).
- All the maintenance of vehicle including change of parts and lubricants on regular basis will be borne by the vehicle owner/ transporter. Only HSD & 1lit. Mobil Oil/ 1000 K M will be supplied by the Milk Union.
- An agreement will be signed between transporter and Tamralipta Co-op Milk Producers' Union Ltd. for the purpose.
- A 'log book' must be maintained on behalf of TAMUL for the said vehicle in which details of journey and HSD& MSD supplied will be noted.
- The rate should be valid up to one year from the date of issue of this work order.
- The vehicle must be kept in the BMCU campus at night.


