A. Description of Works:

B. Terms and Conditions:

1. Every intending bidder must quote rate for all three categories stated above. The lowest quote clubbing all the above three categories will be the decisive factor subject to fulfilment of other terms and conditions as laid down below.
2. Each bidder must have at least 20 (twenty) numbers of hoarding having size of 20' x 10' on prominent areas of the district of Purba Medinipur and the list of those ought to be mentioned in response to this notice along with tax receipt of the local bodies for the F.Y 2016-17.
3. Each bidder must have either its own equipments for printing on flex having a depth of at least 320 gsm and at least 720 dpi or a valid agreement with a reputed printing organization possessing the required standard with a view to maintaining the quality control. The copies of such corroborative evidence must be enclosed.
4. Each bidder should submit the copies of latest trade license, P. Tax, PAN, enrolment under GST etc.
5. Each bidder must submit credential of the work of similar nature in government sector. To be clearer work completion certificate and / or payment certificate will be considered as the eligibility of the intending bidder but not only any viable work order.
6. Failure to comply with the work order timely, if issued later in favour of the selected bidder, arisen out of this notice will summarily be treated as a wilful breach of contract and may lead to cancellation of rights to the selected bidder getting work orders of similar nature in future.
7. Every bidder must mention at least one valid e-mail Id and at least one valid mobile phone number to get communicated with for this purpose. Posting of subjects and or link to be downloaded the advertising matters will be treated as an effective communication from this end.
