TERMS & CONDITIONS:

1. The tenders should be submitted in the official Letter head of the interested Bidders.
2. The tenders should be submitted to the tender drop box in the office of the undersigned.
3. The interested Bidders must have the ability towards uninterrupted supply of drugs and consumables round the clock.
4. The bidders have to submit self-attested copy of their following documents at the time of submitting the tender.
i) Trade Licence. ii) PAN. iii) Latest Income tax return. iv) Valid Drug License Certificate
5. The Bidder(s), who do not fulfill any of the conditions of incomplete in any aspect, are liable to be summarily rejected.
6. Payment will be made to the bank A/C from the office of the Superintendent and Secretary, Egra Sub-Divisional Hospital Rogi Kalyan Samity after receiving of invoice(s) along with the requisition slip/ Supply order from the selected suppliers utilizing the Janani Shisu Suraksha Karyakram (JSSK) and others programme of the said Samity.
7. The tender quoted rate will be in form of uniform percentage of discount on MRP of all Drugs and Consumables. The lowest accepted tender will have the highest discount level over the MRP. Under no circumstances the rate shall not be more than the printed MRP. Discount percentage should be quoted in both words and figures separately.
8. Interested suppliers may collect the details about Drugs and Consumables and others details under Cashless Delivery Scheme from the office of the undersigned (Store Division) in any working days during office hours.
9. The bidders himself /herself of his /her representative may remain present during the time of opening of tenders.
10. No further discussion / interaction will be held with the bidders whose bids will be rejected / disqualified.
11. The undersigned has reserved the right to accept/reject any or all tenders fully or partially at any course of tender process without showing any reasons.
12. The bid rate shall valid up to 31-03-2019.


