Notice inviting expression of Interest(EOI)

Sealed EOI are invited from intending supplies for supply of spectacles to School children and elderly person attending to Haldia Sub-Divisional Hospital, OPD.

Terms & Conditions :

- 1) The price of per spectacle as per government order will be Rs. 350.00(Three hundred fifty only) including all charges. Since the price is fixed, we will select best quality spectacle (with Plastic or Lather cover) at Rs. 350.00, so the willing suppliers are requested to submit their sample spectacle along with other requisite documents.
- 2) The average number of spectacles per month may be 80(eighty) number and it may vary depends on OPD Patients, and the hospital authority will not responsible for this.
- 3) This EOI will be valid for three months or bill upto Rs. 99,750.00 whichever is earlier.
- 4) This rate should be inclusive of all charges including taxes and delivery charge as applicable.
- 5) The EOI must be submitted to the office of the undersigned on or before 29.06.2018 upto 11.30 AM and The EOI will be opened at the office of the undersigned on the same day on 1 PM before the EOI selection committee in presence of the supplier or their authorized representatives who choose to attend on the date and time as specified. The EOI documents received after scheduled time will be summarily being rejected without assigning any reason thereof. In any unavoidable reason the date of opening may be changed.
- 6) The application for EOI must be submitted in official letter pad along with photocopy of a) Valid trade license for the financial year 2018-19, b) PAN Card, c) Latest Income Tax Return(not before the Assessment Year 2017-18) d) Valid GST registration certificate e) self attested copy of this EOI notice, f) experience certificate to supply any govt. institutions (if any).
- 7) The willing suppliers must have the ability to supply spectacles at OPD site of Haldia SD Hospital. So, they must sit at Haldia SD Hospital OPD Site at least one day in a week (day will be fixed by hospital authority)(from 11.00 am to 2.00 pm) to receive prescription for spectacles and distribute spectacles to Patient party. And spectacles must be delivered with in 7 days of the supply order.
- 8) If any spectacles found defective the supplier will liable to change it with out any extra cost.
- 9) The bills of successful supplies of spectacles must be submitted with in 5th day of the next month, otherwise hospital authority will not be liable for the payment of the bills.
- 10) The undersigned reserves the right to accept or reject any or all EOI without assigning any reason in any step whatsoever.
