Sealed Expression of Interest are hereby invited from the owner of resourceful, experienced, reputed and registered local (Centre situated within walking distance from hospital) Pathological Laboratory/ USG/ X-Ray Clinic for engagement of Pathological Laboratory/ USG/ X-Ray Clinic for pathological & Others test under different Government Programme for Haldia Sub Divisional Hospital, Haldia, Purba Medinipur, for a period of one year from the date of execution of the agreement with them.

EOI must be submitted at the office of the undersigned- From 16.11.2018 to 29.11.2018 till 1 PM.

Opening of EOI- At 2.00 P.M. on 29.11.2018. (In any unavoidable reason the date of opening may be changed)

Terms & Conditions:-

1. The interested parties must have the ability towards uninterrupted execution of the said work round the clock.
2. Attested photo copies of a) PAN card, b) valid Trade License, c) Income Tax Return(not before the Assessment Year 2017-18), d) Valid GST registration certificate(if applicable or declaration regarding below turnover), e) valid Clinical Establishment license should have to be submitted along with the EOI papers.
3. The test report must be submitted to the hospital authority with proper acknowledgement within reasonable time in case of indoor patient and in case of outdoor patient report may be handed over to the patient party with proper signature & phone number of the patient party.
4. Payment will be made from the office of the Superintendent and Member Secretary, Haldia Sub-Divisional Hospital Rogi Kalyan Samiti after receiving of bills along with the sign requisitions slip from the selected Clinic. In case of test under West Bengal Health Scheme,2008 test code must be written on bills and bills must be submitted with in 5th day of the next month otherwise hospital authority will not be liable for the payment of the bills.
5. The EOI will be the ability to done pathological/ radiological/ others test under government fixed rate in case of selected test enclosed with this EOI notice (Under no circumstances the rate shall be more than the fixed Government rate). And in case of other test interested parties are requested to submit an uniform percentage of discount on the basis of revised rate mentioned in the West Bengal Health Scheme,2008 (Notification No-796-F(MED) dated-31.01.2011).
6. EOI must be submitted in uniform percentage of discount (Clearly written in words) on Revised Health Scheme,2008 rate, not on discount of test wise.
7. The centre must have the ability to done all tests in his category by his own capacity or hiring basis.
8. The EOI, which do not fulfill any of the conditions or incomplete in any aspect are liable to be summarily rejected.
9. The undersigned has reserved every right to accept/ reject any or all EOI fully or partly at any course of EOI process without showing any reasons.
10. Selected quotationers have to execute a contract as per prescribed pro forma in a non judicial stamp paper worth Rs. 10.00
