12. The supply and installation works should be undertaken under the supervision of the Head Clerk and the final bill would be certified by him.
13. The participating quotationers will have to undertake the comprehensive Annual maintenance of the supplied equipment for a period of five years. For a period of three year after installation, the unit will be covered under warranty, hence only charges of consumables shall be payable. The subsequent years shall be under AMC and the cost shall be quoted separately. The AMC will comprise of the following:
 - (i) Scheduled Preventive Maintenance: This is to be carried out every six months intervals. In this time, the activated carbon block and sediment filter is to be replaced, the refrigeration circuit is to be serviced.
 - (ii) Breakdown Maintenance: the breakdown of the complete equipment (water purifier) is to be attended throughout the year. All the materials required for repair/replacement of any component /system shall be arranged by the party. All the parts to be used shall be sourced from Original Equipment Manufacturer/their authorised distributor.
14. The terms of reference of the work for which the quotation is invited includes requirement based designed, supplying, fixing/fitting of the water purifying units and commissioning the same including fixing of user guide (Do's and Don'ts) in laminated bond within fifteen days from the date of work order
15. Selection of lowest bidder is not mandatory. The CMOH authority reserves the right to reject/cancel any quotation without assigning any reasons what so ever.
