The said fees are payable in cash directly against Cashier's receipt and copy of receipt is compulsory is to be attached with the application form while dropping.

Terms and conditions :-

1. Type of Business to be carried on must be mentioned in the application.
2. The accepted leasee will have to pay 100% of gross value in lumpsum at a time against each stall within 15 days before performing the necessary agreement failing of which any claim from accepted leasee will not be entertained by the undersigned.
3. Day to day maintenances to keep the assets in good condition will be done by the accepted leasee at his/her own cost. No addition, alteration, renovation, extension or demolision will be allowed provided permission in this regard is taken in due time.
4. The leased out stall is not resaleable or transferable in any manner. 'Power of Attorney' or any type of 'WILL' is not applicable.
5. This Panchayat Samity will remain as the sole owner of leased out stall/stalls always. If the leasee wants to terminate this lease agreement then it is compulsory that the stall (s) will be returned to this Panchayat Samity but not to others.
6. The Monthly rent will be enhance by the authority as per Govt. rules after every three years and agreement renewed by the authority.
7. Cost of electric meter connection etc. will be borne by the leasee .
8. In case of any unlawful activity or activities deemed to be detrimental to the interest of Ramnagar -I Panchayat Samity or public in general the right of lease and lease contract shall be terminated.
9. In case of alternate structural arrangements or customization, it would be supervised and accorded permission by the E.O, Ramnagar-I Panchayat Samity. Permission shall be accorded after payment of compensation as determined by the udnersigned.
10. Time Period of maximum lease as per law.

12. The Leased out Stall will be use only selling Show Room not Go-down.
13. The Stalls are leased out for only 25 years from the date of agreement on basis of satisfactory renewal of agreement after every three years with the authority.

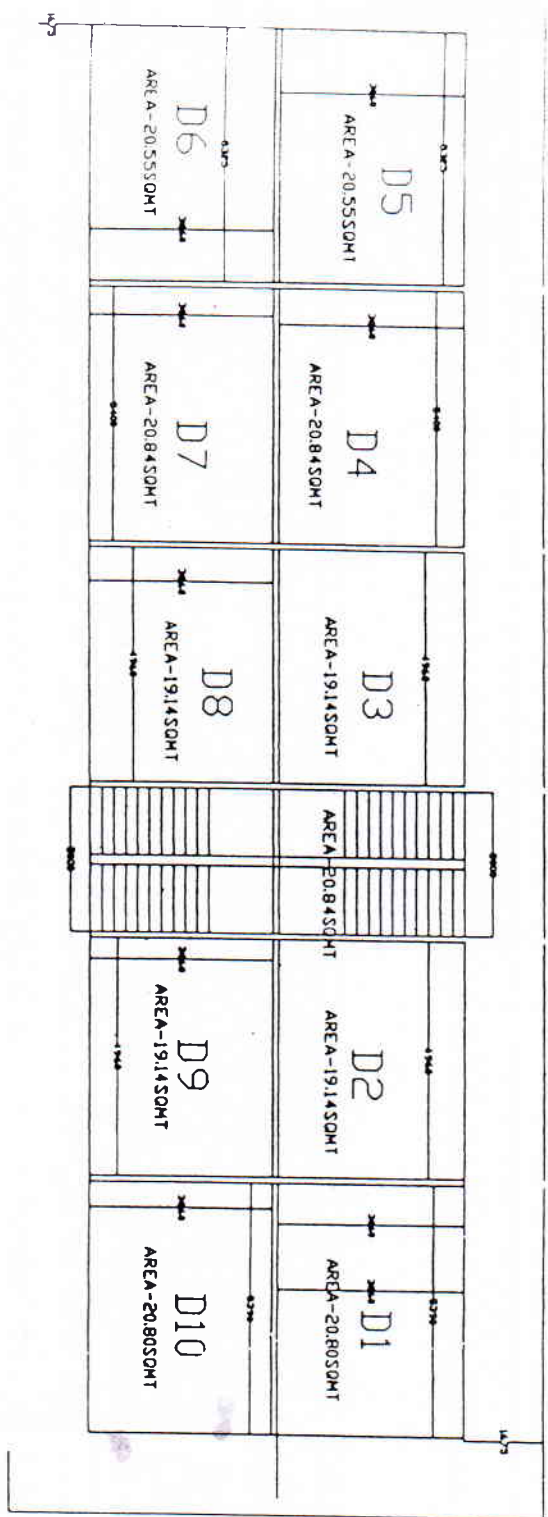
