
NOTICE INVITING TENDER

Sealed tender are invited from the bonafied farms/ organization/ transporter in respect of engagement of Transporter(s) having 'Insulated Milk Tanker' of capacity (a) 5000-5200ltrs.,(b) 7000-7300ltrs.,& (c)10000 - 10500 ltrs. respectively for delivery of raw chilled milk from different BulK Milk Cooling Unit(BMCU) of Tamralipta co-operative Milk Producers' Union Ltd., Purba Medinipur to different Govt. Dairy Plants (Mother Dairy Calcutta, Dankuni/Central Dairy, Belgachia) with maintaining following terms & condition :-

1. The Tenderer should submit the offer rate in sealed envelop superscripted with 'Tender for Insulated Milk Tanker' along with valid documents addressing to the Undersigned in the above mentioned address.
2. Milk Tanker must have valid road permit, PAN, Tax clearance Certificate, Blue Book, Valid Insurance Paper, Valid Smoke Certificate and other relevant documents.
3. The tenderer has to be submit in their own 'printed letter head' specifying the rate/KM separately for each item clearly in number and words which will include all type of road expences, toll charge etc.
4. The intended tenderer should furnish a credential of similar nature of work performed with Central Govt./ State Govt./ any PSU/ Corporate body within last 3 years.
5. An agreement will be signed between selected transporter & 'Tamralipta Co-operative Milk Producers' Union Ltd.' in a Rs.50/- nonjudicial stamp paper (in tenderer name) before execution of the work.
6. The tenderer must submit the Xerox documents of vehicle ownership paper/ contract paper, PAN, ADDHAR, Bank loan paper(if applicable), last year tax clearance etc.
7. Requisition of type of tanker will be based on milk collection. Presently the 5000 ltrs Tanker will run in every alternate day and latter it can ply everyday.
8. A 'Log Book' must be maintained on behalf of TAMUL for the said vehicle on which details of journey will be noted and duly signed by the TAMUL authority.
9. Initially the rate should be valid for 6(six) month from the date of issue of this order and may be extend further depending upon the situation.
10. The interested tenderer has to submit Bank Demand Draft(Non -Refundable) of Rs.200/- along with tender paper in favour of 'Tamralipta Co-operative Milk Producers' Union Ltd.' payable at Tamluk, Purba Medinipur. **Submission of TENDER without D.D will not be accepted.**

Sealed tenders should reach to the office of the undersigned within 2.00PM on 29.01.2018 and will be opened on 30.01-2018 in the office of the Undersigned/ or the Deputy Director ARD & P.O, Purba Medinipur at 1.00 P.M .
