The intending tenderers may drop their tenders in the box which will be kept in the chamber of the Sub Divisional Officer Contai up to 3.00 PM on 22.10.2018 and the same will be opened at 4.00 PM on the same day, when the tenderers may remain present.


The rate should be quoted per unit both in figures and words as per schedule enclosed. The work should be completed within the stipulated time, extension of time beyond the date fixed will not be allowed under any circumstances. The work should be completed as per specification and as detailed above and also as per direction of the authority concerned. Any deviation or failure to supply the materials in time will be viewed seriously. The earnest money so deposited by the accepted tenders will be converted into "Security Deposit" which may be forfeited if the work is not completed satisfactorily within the schedule time. The tenderers should abide by all the terms and conditions as laid down in the Government Rules. Claim for any extra charge will not be entertained under any circumstances.

In case of civil work related to some electrical arrangement the rate should be quoted by the tenderer including the cost of installation, dismantling, hire charges of materials, transport charges, supplying necessary rope, wire etc. & fitting and fixing charges.

The undersigned reserves the right to accept or reject any/ all tender or split up the work amongst the tenderers, if necessary, without assigning any reason thereof.


