Sealed tender are invited in prescribed format from the reputed/bonafide owner of the goods vehicles/agencies/transport authorities for the distribution of total 345422 (approx) nos. of different types of Free Text Books of class XI & XII for the session 2017 from the Godown of District Inspector of Schools (SE), Purba Medinipur at Nimtala SSM Book Godown, P.O.- Salgechhia, P.S.-Tamluk, Dist- Purba Medinipur to 45 nos. of Circle offices situated in different Block of the district as per list (Circle wise and subject wise no. of books) will be provided at the time of books distribution.

Terms and conditions


- 01.All valid documents of vehicle/ vehicles (registration certificate, permit, tax clearance, insurance etc.to be submitted with the quotation.
- 02.The total rate for delivery of all books to 45 Circle point including vehicles, fuel cost, binding cost if necessary, loading at district godown and unloading cost of labour at circle point, must be quoted in the application form in words and digits.
- 03.The rate should be quoted for distribution of books by using of different types of vehicles in capacity of upto 1.5 ton / upto 3 ton / upto 6 ton / upto 8 ton and beyond 9 ton as and when required.
- 04.A demand draft amounting to Rs. 5000/- (Rupees five thousand only) in favour of District Inspector of Schools (SE), Purba Medinipur must be submitted with the application as earnest money which will be refunded to unsuccessful Tenderer immediately and to successful Tenderer, after completion of the book distribution work successfully.
- 05.Tenderer will be liable for any loss or damages of the books at the time of distribution.
- 06.Earnest money will be forfeited if the successful Tenderer fails to distribute the books in due course.
- 07.TDS/VAT/TAX if any will be deducted as per norms of the Income Tax Act. 1961.
- 08.Authority has right to reject or cancell any/ all quotations without showing any reason thereof.
- 09.Book distribution will be completed by 02.06.2017 by two phases as per requirement.
- 10.The Tenderer will submit Xerox copy of their Voter Identity Card/Ration Card and PAN card (Self attested) at the time of submission of quotation.
