CERTIFICATE

- 1) Deletion has been done only on the basis of Form 7 or on the basis of a request of deletion made by the concerned elector in Form 6 due to shifting from one AC to another or in Form 8A shifting within the AC
- 2) In case of deletion due to death, the ERO has satisfied himself about the fact of death of electors by re-verifying the evidence.
- 3) In case of deletion because of duplication entry, the ERO made a certification in the concerned file in his own hand that he has verified and is satisfied that this entry is a duplicate entry.
- 4) Intimation about the deletion has been sent to the elector concerned (or to the near relatives in case of death cases) through Special Messenger or by post or SMS or e-mail, in case mobile number/e-mail ID is available in the electoral database and the acknowledgement/proof of which is on record at the office of the ERO/Concerned BDO(s).
- 5) Part wise list of Names proposed to be deleted from the electoral roll on any ground has been displayed in his office for a period of at least 7 days for public information and calling for objections, if any.
- 6) Partwise list of names proposed for deletion has been handed over to the local units of all political parties.
