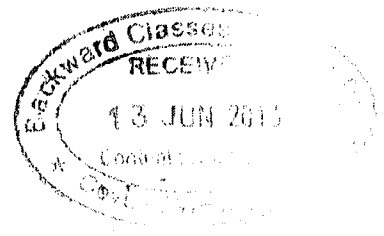

Subject:- Changes in the Centrally sponsored scheme of Pre-Matric Scholarship to Children of those engaged in 'Unclean' occupations.

Madam/Sir

The Scheme of Pre-Matric Scholarship to children of those engaged in 'unclean' occupations aims to provide financial assistance for pre-matric education to children of the following target groups, viz. i) scavengers ii) sweepers having traditional links with scavenging, iii) tanners, and iv) flayers.

2. The above Scheme is further extended to the children/wards of those engaged in waste picking/collecting. The change will come into force with effect from 1.5.2013. A copy of the revision of regulations of the Scheme, incorporating the above changes is also enclosed.

3. State Governments/ UT Administrations are requested to publicise the above changes urgently and send a proposal for Central Assistance for the year 2013-14, in the light of the above revision of the Scheme, before 15<sup>th</sup> June, 2013.
