NOTIFICATION

In continuation of the notification vide 564/1-(4) /XIX/VII/46/DCPS, dt. 11.06.2019 and as it has been found that sufficient number of applications for CHILDLINE Services has not been received from the NGOs, hence the time period for submission of application for selection of the NGO to run the CHILDLINE Services in the District, Purba Medinipur is further extended for the period of 11 days from 18.06.2019 to 28.06.2019.

In pursuance of the letter vide memo no 1033(3)/CRT, dated 21.05.2019 of the Director of Child Rights & Trafficking, Government of West Bengal regarding running of CHILDLINE Services in the Purba Medinipur District, the interested NGOs are invited to submit their applications for selection of the NGO to run the CHILDLINE Services in the District, Purba Medinipur. The application must be submitted by 28.06.2019 along with following requirements:-

1. Copy of the registration of the NGO duly attested by the Secretary/President of the NGO.
2. Copy of approval of Managing Committee by the District Magistrate duly attested by the Secretary/President of the NGO.
3. Copy of audit report of previous three years duly attested by the Secretary/President of the NGO.
4. Activity of the NGO.
5. Credibility for running the CHILDLINE Services.

The application including requisite documents should be submitted to CA to the Addl. District Magistrate (Gen.), Purba Medinipur in sealed envelope with nomenclature "Application for CHILDLINE Programme in Purba Medinipur District" by 28.06.2019 within 4:30 p.m.
