**ORDER**

In terms of Notification No. 1682-SW/O/2M-16/09 dated 01/06/2011 of the Department of Women & Child Development and Social Welfare, Government of West Bengal to introduce the West Bengal Disability Pension Scheme 2010, Sanction is hereby accorded for **DISABILITY PENSION** to the following pensioners ( in Annexure-A) with effect from 01.06.2014. The sanction of pension will be governed by Disability Pension Rules 1990 & subsequent amendment, which had taken place or will take place in future.

1. The rate of aforesaid pension will be Rs. 750.00 (Rupees Seven hundred Fifty) only per month which may be changed subsequent Government Order in future.
2. The Pension sanctioned will continue until it is revoked, stopped, held up or got lapse due to death of pensioner or any other causes.
3. The amount of pension will be remitted by Bank Saving Account only.
4. The Charges will be debitible to the Head "2235-02-101-NP-005-V-04-Pension/Gratuities" for Disability Pension sanctioned under **NON-PLAN** Head.
5. The Sub-Divisional Officer, the Block Dev. Officer or the Executive Officer of Panchayat Samiti may depute one or more officers to visit as often as may be possible but not less than once in six months to the areas in which the pensioners in recorded to live so as to be satisfied that the pensioner is alive and continues to be eligible for pension.
6. If the sanctioned pensioners get any other pension from any other Department this will be treated as cancelled.
7. Life Certificate must be submitted to the sanctioning authority once in a year by the first week of November each year.
8. No G.R. will be given to the applicants.
