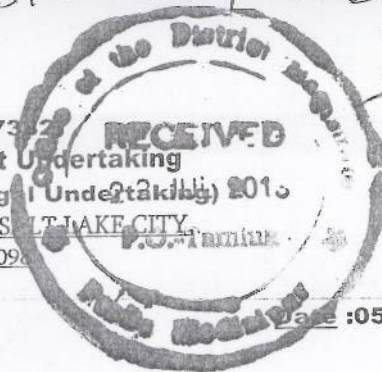

Subject : Extending the benefits of NHFDC Term Loan to the persons with disabilities.

Madam/Sir

National Handicapped Finance and Development Corporation (NHFDC) has been functioning as an apex institution for assisting a wide range of income generating activities for promotion of economic development and self-employment by giving the loan to the persons with disabilities through Women Development Undertaking of this state. Accordingly, Term Loans have been given to the persons with disabilities (minimum 40% disabilities) with nominal rate of interest on repayment since 2001 in this State.

During last few years it is experienced that there is declining trend in submission of loan applications from persons with disabilities & poor loan repayment from loanees etc. It was resolved in the last review meeting taken by the Secretary, CD Deptt. And WD&SW Deptt. on 04.07.13 that the following measures will be taken to improve our performance.

Accordingly, you are requested to:

- i) Ensure submission of at least two(2) applications from each block by September, 2013;
- ii) Provide facilitation to the prospective loanees for submission of application;
- iii) Utilize service of IDO (Industrial Development Officer) for checking of the project proposal as well as helping the prospective loanees in preparation of project proposal;
- iv) Undertake visit to the existing loanees for monitoring and providing support and to enquire about repayment;
- v) Ensure visit to every loanee after sanctioning of loan for monitoring of project and forwarding it to WBWDU through proper channel within three months after starting of business by the loanee;
- vi) Ensure compliance of the direction of from the court of Chief Commissioner for Persons with Disabilities, Govt. of India that all officials and employees dealing with schemes of NHFDC are to be more polite with persons with disabilities. (Related letter of NHFDC No. NHF/2/22(8)/13 83919 dated 29.5.13 has already been communicated to the district for onward transmission);
