**ORDER**

Sanction is hereby accorded towards payment of Maintenance Charges to S.C. students as per quota fixed for the year 2013-2014 as stated below.

Backward Classes Welfare Department, has sanctioned an amount of Rs. 17,39,000/- (Rupees seventeen lakh thirty nine thousand only) under G.O. No.5028/BCWDS, dated-16.09.2013, and placed at the disposal of the District Welfare Officer, Backward Classes Welfare, Purba Medinipur. Out of the entire fund of Rs. 17,38,400/- (Rupees seventeen lakh thirty eight thousand and four hundred only), is hereby sub-allotted to different Blocks and an amount of Rs. 600/- (Rupees six hundred only) is lying balance as noted below.

The concerned Block Development Officer, is hereby authorized to draw the amount so sub-allotted against each of the Block as per quota to be disbursed the same to poor eligible S.C. students for remaining 7 months @Rs.40/- p.m. and utilisation certificate to be submitted to this end within 15<sup>th</sup> days from the date of disbursement.


