**N O T I C E**

In exercise of the power conferred upon the State Transport Authority under Section 68(4) of the Motor Vehicle Act, 1988, read with rule 86 of the West Bengal Motor Vehicle rules, 1989 and as per the direction of State Transport Authority vide Memo No. : 419(3)/STA Dated 09.06.2014, notice is hereby given inviting applications from the interested candidates for issuance of **Permits for new AC and Non-AC Metered Taxi in the area under the jurisdiction of Haldia Development Authority.**

Such permits may be issued by the concerned RTA subject to strict adherence to the following guidelines :

1. Value added services i.e. two news papers (one each in Bengali and English vernacular) and music system, shall be made available in all new AC Metered Taxis at no extra cost;
2. Selection of operators for both AC and Non-AC Metered Taxis should be done strictly on merit as per section 74(3) of the Motor vehicles Act, 1988;
3. Each applicant should submit an Affidavit, sworn on Non-Judicial Stamp Paper before a Magistrate or Notary Public alongwith the application for Permits to the effect that he would abide by all the conditions mentioned in the letter and further undertaking that operation of the vehicle shall not be stopped due to any call of Strike, Bandh, Hartal etc. on any date and further to the effect that there shall be no refusal to accept passenger on hire by the driver while driving the vehicle at any place and at any time of the day and night. This may be an additional condition of the permit so issued;
4. Fare rates for both Ac and Non-Ac as may be applicable, including night time additional charges shall apply. However, the passenger shall have a choice of using or not using the AC in an AC Metered Taxi and the fare should be charged accordingly depending on the actual nature of use.
5. The technical specification, colour and marking specifications for the Metered Taxis to be issued such permits shall be as per Transport Department's No. : 2183-WT/3M-5-/2013 dated : 30.05.2014.

In exercise of the power conferred upon the State Transport Authority under Section 68(4) of the Motor Vehicles Act, 1988, read with Rule 86 of the West Bengal Motor Vehicles Rules, 1989, the State Transport Authority, West Bengal hereby directs the following Regional Transport Authorities to issue permits for metered taxis (AC or Non-AC) for the areas in the manner as detailed below:

SL	RTA	No of Permits	Area
1	Burdwan	500	Burdwan Development Authority area
2	Burdwan	500	Asansol-Durgapur Development Authority & Asansol - Durgapur Police Commissionerate areas
3	Paschim Midnapore	500	Midnapore - Kharagpur Development Authority areas
4	Purba Midnapore	200	Haldia Development Authority area

Such permits may be issued by the concerned RTA subject to strict adherence to the following guidelines:

1. Value added services i.e. two news papers (one each in Bengali and English vernacular) and music system, shall be made available in all new AC metered taxis at no extra cost;
2. Selection of operators for both AC and non-AC metered taxis should be done strictly on merit as per Section 74(3)(b) of the Motor Vehicles Act, 1988;
3.
