

Renewal fees will be received in cash at respective centre against DCR from 11.00 A.M. to 03.:00 PM Before renewal, the licence holders have to apply in prescribed proforma (Enclosed) to be checked by the respective Magistrate entrusted with the work. The licence holder have to produce their original arms licence with Arms & Ammunitions alongwith self documents such as EPIC Card, Recent Photo etc.

After completion of renewal, one photo copy of said proforma with **UNI No** (to be supplied by the Arms Section, Dist. Head Qtrs) to be submitted before the Officer-in-Charge, Arms & Explosive Section in District Head Qtrs for necessary entry in NDAL software.
