ORDER

In pursuance to the Order of Personnel & Administrative Reforms Department vide Memo No. 1275/PAR(AR)/O/3M-23/2014 dated 13<sup>th</sup> November, 2014 regarding adoption of the provisions of “self-attestation” in lieu of “attestation by gazetted officers and others” and “self- declaration” in lieu of “affidavit” and in partial modification of this department’s Order No. 1911/FES/O/3S-26/2014 dated 19/11/2014, it is hereby further ordered that :-

- A. For issuance or renewal of fire license under the delegated authority of District Magistrate for storing of Kerosene Oil upto 2000 lts. according to Circular No. 1895-FES/O/2E-12/2004 (Pt. -I) dated 28/12/2012:

The process of submitting “Affidavit sworn before a magistrate” shall be replaced by “self-declaration” to be submitted by the Applicant along with the application as prescribed in the schedule under West Bengal Fire Service (Fire License) Rules, 2004.

The process of submission of “self declaration” in lieu of “affidavit” for granting N.O.C./Fire Safety Certificate in respect of complex projects and for granting permission for erection of temporary structures of large size, as specified in this department’s Order No. 1911/FES/O/3S-26/2014 dated 19/11/2014, shall continue.

The Applicants shall submit “self-declaration” in the format prescribed in Annexure – I.
