Whereas the existing process of paper based application for renewal of Fire Licence, to offline mode, by the authorities of officials of state holders under West Bengal Fire & Emergency Services has been discontinued on and from 15th March 2018 by issuance of Order No. 339/FES/0/2F-155/2016 dated 28.02.2018

And whereas as District Magistrates were delegated authority to issue or renewe Fire Licences for Kerosene Oil upto 2000 ltrs. Vide Go No. 1894-FES/O/2E-12/2004(pt.-I) dated 28.12.2012

And whereas there was no exclusive provision for the District Magistrates in the Web based system of issuance and renewal of Fire Licences for upto 2000 Ltrs of Kerosene Oil and as such the District Magistrates were allowed to continue to issue or renewe Fire Licence for Kerosene Oil in existing offline mode upto 2000 ltrs. upto 31.03.2019 by dint of Order N. 562/FES/O/2E-155/2016 dated 11.04.2018

And whereas it appear that the process of inclusion of exclusive provision for District Magistrates by updating the web based system of issuance and renewal of Fire Licences for Kerosene Oil upto 2000 will take some time.

And whereas all supporting documents had been produced in the month of Nov. & Dec. 2018 by K. Oil Dealers for renewal of Licence upto Dec. 2019.

Therefore, in terms order No. 120/FES/O/2E-155/2016 dated 18.01.2019 of the Additional Secretary to the Government of West Bengal Department of Fire & Emergency Services notice is hereby given to all concerned to submit application with original Fire Licence for renewal upto 31.12.2019.

ORDER

WHEREAS the existing process of paper based application for renewal of fire license, in offline mode, by the authorities or officials or stake holders under West Bengal Fire & Emergency Services has been discontinued on and from 15th March, 2018 by issuance of Order No. 339/FES/O/2E-155/2016 dated 28/02/2018.

AND WHEREAS District Magistrates were delegated authority to issue or renew fire licenses for kerosene oil up to 2000 litres vide G.O. No. 1894-FES/O/2E-12/2004 (Pt-I) dated 28/12/2012.

AND WHEREAS there was no exclusive provision for the District Magistrates in the web based system of issuance and renewal of fire licenses for up to 2000 litres of Kerosene Oil and as such the District Magistrates were allowed to continue to issue or renew Fire License for kerosene oil in existing offline mode up to 2000 litres up to 31st March 2019 by dint of Order No. 562/FES/O/2E-155/2016 dated 11/04/2018.

AND WHEREAS it appears that the process of inclusion of exclusive provision for District Magistrates by updating the web based system of issuance and renewal of fire licenses for Kerosene Oil up to 2000 will take some time.

THEREFORE, after careful consideration, it is ordered that the District Magistrates shall continue to issue new or renew Fire License for kerosene oil in existing offline mode up to 2000 litres up to 31st December 2019. District Magistrates will send information of such S.K. oil dealers to the department for updating the records in the web based system.
