ORDER

In connection with renewal of Arms Licences (Small & Big Arms) which will be expired on 31.12.2017 to be renewed by the respective SDO for their sub-division area within 31.12.2017. It is noted that **NO LICENCE WILL BE RENEWED WITHOUT UIN (Unique Identification Number)**. It is also noted that as per arms rule 2016 an application for renewal of a licence for arms or ammunition shall be filed by the licensee in the Form wherein specified at least **sixty days prior to the expiry of the said licence** and on receipt of an application for renewal thereof under section 15, the licensing authority shall call for a report of the officer-in-charge of the nearest police station on that application, and such officer shall send his report in Form S-4, within a period of thirty days from the date of receipt of letter/application by him.

The programme in this regard to be decided and conducted through wide publicity by the SDO for their sub-division area except Tamluk.

Following procedure to be maintained at the time of renewal of Arms:

Renewal fees (fees mentioned in new arms rule-2016, Page No-276 to 279) will be received in cash at respective centre against DCR from 11.00 A.M. to 02.00 PM

Before renewal, all documents for renewal to be checked by the respective Magistrate entrusted with the work. The licence holder has to produce their original arms licence with Arms & Ammunitions alongwith self attested Adhar Card, EPIC Card, PAN , Recent Photo etc.

After completion of renewal, one photo copy of said proforma with **UNI No, EPIC Card, Adhar Card** and **fees details** to be submitted before the Officer-in-Charge, Arms & Explosive Section in District Head Qtrs within one month for necessary entry in NDAL software. It is noted that list of licencee with UIN had been sent to you last year by the Arms Section, Dist. Head Qtrs.
