A sum of **Rs. 4,22,64,225.00** (Rupees four crore twenty two lakh sixty four thousand two hundred and twenty five) only vide Memo No. 171(Sanction)-PN/P/II/1G-6/2010, Dtd. 19.09.2019 as " Untied Grant for Development Purpose" against 1st Installment of 2019-20 on allocation of the 4th State Finance Commission has been received from the Government of West Bengal, Panchayat & Rural Development Department.
